## STAFF AND CHILD IDENTIFICATION KEY INSTRUCTIONS FOR USE

Per the statutes listed below, the department is required to protect the confidentiality of staff and child information. Use of a key is mandatory, but this is not a required form. You may use staff record checklists, child record checklists, or any other key to meet the requirement.

Per 48.657(1), Wis. Stats., the department may not disclose the identity of any employee of the child care center when providing information about violations of statutes, rules, or provisions of licensure. Therefore, if the licensing specialist needs to refer to a staff person in a noncompliance statement or enforcement document, the licensing specialist shall enter the staff person's name and position name into the "Staff / Family Member / Other Adult" column and use the corresponding letter to identify the staff person throughout that document. **Child Care Certification:** While not a statutory requirement, maintaining the confir antiality of any employee is considered best practice and DCF-F-CFS0294-E's issued to certified ope after should not disclose employee names.

Per 48.78, Wis. Stats., the department, a licensed child care center, or a certified child care program may not disclose any information about children in care; therefore, if the licensing specialist / certification worker needs to refer to a child (or parent of a child) in a noncompliance statement or enforcement document, the licensing specialist / certification worker shall enter the child's (or parent's) name into the "Child Name / Birthdate" and "Staff / Family Member / Other Adult" columns and use the corresponding number to identify the child (or parent) throughout that document.
