

1	<p>251.055(1)(a) <b>Supervision Of Children</b></p> <p>Description: Per self report from the Center Director, on 3/7/25 a child ran down the hallway and hid from the group of children and teacher as they were transitioning from the playroom to the bathroom. The teacher then left the group of children unattended to look for the child.</p> <p>Repeat violation: Previously cited on 5/15/2024, 12/13/2023</p>	<p>The teacher has been written up for leaving children unattended.</p> <p>Training has also been done with all staff along with implementing tools to help keep all the children together within sight and sound.</p> <p>The tools that have been implemented are:</p> <ol style="list-style-type: none"> <li>1. A shape rope or walkodile for transitions in the hallways.</li> <li>2. Stop signs up at every corner in the hallways, on the playroom door, by the parent board before going outside, and inside and outside the big bathroom. The teachers are to count how many children are on the rope, match them with the children listed on their clipboard, and make eye contact with each child at every stop sign they come across in the building.</li> <li>3. During transitions in the hallways the teachers are to sing songs and/or do fingerplays to keep the children's attention, while still using the shape rope or walkodile.</li> </ol>	3/24/25
