

2	251.07(2)(e)3. <b>Prohibited Actions - Physical Restraint, Restriction, Enclosure</b>  Description: A child care worker used prohibited actions, physical restraint in December 2023. The worker grabbed a school age child by the trunk of their body and pulled them into the classroom and then utilized a hug/restraint until the child calmed down.	The child was sitting on the floor in the doorway of the playground door refusing to go any farther into the room. The staff member slid the child into the room by his thighs in order to shut the outside playground door, as it was December and very cold outside. The child allowed the teacher to hug him until he was calm. He was able to leave the teacher's hug anytime he wanted. The teacher was reminded that any physical restraint can only be used to protect the child or others from harm.	2/20/2024
