

The worker was not aware that the child was left in a bathroom while the rest of the class evacuated.</p> <p>Repeat violation: Previously cited on 10/7/2024, 9/16/2024</p>	All staff were retrained on transitions and child tracking using our Child Supervision Record at a staff meeting.	3/19/26
