Dear Ms. Picha:

This letter constitutes statutory notice of an imposed direct forfeiture assessment on you, Sheryl Picha, in the operation of Sprout Childcare, a licensed group child care center. This letter identifies the licensing statutory and/or code violations that were identified at Sprout Childcare, additional sanctions and penalties that may result if these violations are not corrected and informs you of your appeal rights.

The Wisconsin Department of Children and Families (Department), under the authority of Wis. Stat. § 48.715, provides for sanctions and penalties where persons operate a group child care center in violation of Wis. Stat. § 48 or Wis. Admin. Code § DCF 251. Sanctions and penalties include issuance of orders to stop operating, to correct violations and to submit plans of correction, assessment of forfeitures or revocation of a license. The Department may set forfeiture amounts of \$10.00-\$1,000 per day per violation.

Please note that in accordance with Wis. Stat. § 48.657(2g), and Wis. Admin. Code § DCF 251.04(2)(L), the child care center shall post with the license any notice received from the Department relating to violations. This notice must be posted in a conspicuous area of the center that is accessible to the public and must remain posted until the violations are documented as corrected by the licensing specialist at or before the next licensing site visit.

FORFEITURE ASSESSMENT

On 07/04/19, The Department received a complaint alleging that on two separate occasions, unknown to the staff providing the supervision, a child was left unsupervised on the playground. The complaint investigation determined that on 11/21/18, at approximately 4:30pm, a 3-year old was left unsupervised on the large playground. The investigation also determined that on 07/01/19, at approximately 5:15pm, a child under 2-years old, was left unsupervised on the front

playground. These are serious violations endangering the health, safety and welfare of children in care. The Department imposes a direct forfeiture assessment for the following violations:

1. DCF 251.05(3)(c) states, "Each child shall be closely supervised by a child care worker who is within the sight and sound of the children to guide the children's behavior and activities, prevent harm and assure safety. Contrary to DCF 251.05(3)(c), close supervision was not provided on two separate occasions when a child was left on the playground while staff took the rest of the children into the building.

Forfeiture assessed for this violation: \$200.00

2. DCF 251.05(3)(f) states, "The center shall implement a procedure to ensure that the number, names and whereabouts of children in care are known to assigned child care workers at all times. Contrary to DCF 251.05(3)(f), the center's tracking procedures failed on 11/21/18 and on 07/01/19, when unknown to staff, a child was left on the playground.

Forfeiture assessed for this violation: \$150.00

3. DCF 251.04(3)(i) states, in pertinent part, that the licensee shall report to the department any incident that results in a provider not knowing the whereabouts of a child in attendance at the center within 24 hours of the occurrence. Contrary to DCF 251.04(3)(i), on 11/21/18 and on 07/01/19, unknown to staff, a child was left unsupervised on the playground. Neither incident was reported to this Department as required.

Forfeiture assessed for this violation: \$50.00

TOTAL FORFEITURE AMOUNT DUE FOR ALL VIOLATIONS: \$400.00

A Noncompliance Statement and Correction Plan is issued with this letter. This is enclosed and incorporated herein by reference. (Attachment A.)

FORFEITURE PAYMENT

The total forfeiture amounts due for all violations identified above is \$400.00. Payment should be made payable to the State Treasurer. Send your payment within ten (10) days of the receipt of this notice to the Bureau of Early Care Regulation, Room E-200, 201 E. Washington Ave., Madison, WI 53703. Include the attached remittance notice. Forfeiture payments are deposited in the School Fund.

ADDITIONAL PENALTIES FOR FAILURE TO COMPLY

Failure to correct the identified violations and any subsequent failure to maintain compliance with the Wisconsin Statute and Administrative Code may lead to the imposition of additional sanctions and penalties, as set forth in Wis. Stat. § 48.715. Additional sanctions and penalties may include orders to stop operating, to correct violations, to submit plans of correction, forfeiture assessments, or proceedings to revoke a license. The Department may set daily forfeiture amounts ranging from \$10 to \$1000 per day, per violation.

APPEAL RIGHTS AND PROCEDURE

Any person aggrieved by a Department action taken under Wis. Stat. §§ 48.715, 48.68(1) and/or 48.685, has the right to an administrative hearing under Wis. Stat. § 227.42. Pursuant to Wis. Stat. § 48.72, your written request must be sent directly to the Division of Hearings and

Appeals no later than ten (10) days from the date of this notice; please attach a copy of this notice to your request for a hearing.
